



INTERNATIONAL AGREEMENT

On scientific and educational cooperation between
Jizzakh polytechnic institute and
Karamanoğlu Mehmetbey University (Turkey)

In order to develop mutually beneficial cooperation in the fields of higher education, science and culture, by the rector of Jizzakh Polytechnic Institute Prof. Dr. Usmankulov Alisher Kadirkulovich on the one hand and Karamanoğlu Mehmetbey University, represented by the rector Prof. Dr. Mehmet GAVGALI, on the other hand, have signed this Agreement as follows:

Article I

HEIs have signed this Agreement, intended to strengthen and develop international relations on the basis of various forms of cooperation in the field of education, scientific research and cultural exchange. To this end, high schools claim that each of them, individually and collectively, is committed to complete all activities necessary for the performance of this Agreement and to achieve its objectives, taking into account their possible extension.

Article 2

HEIs on a parity and mutually beneficial basis undertake to promote and carry out the following activities:

- 1) The development of joint plans for a comparative study of following aspects: humanitarian, legal, political, economic, agricultural, technical sciences, language and culture of the countries Participants of the Agreement;
- 2) exchange of publications and research materials between the two HEIs in the field of cooperation;
- 3) tire publication of scientific, educational and training materials on the results of joint work in the field of cooperation
Scientific journals of the Universities;
- 4) the organization of scientific meetings, seminars, courses and conferences in each of the Universities- participants of the Agreement;
- 5) the exchange of teachers, researchers and technical personnel for the development of joint scientific and didactic activities through training, study tours and training practices;
- 6) implementation of training programs for undergraduate and graduate students;
- 7) the joint conducting of diploma and master's courses with the possibility of conferring

Academic ranks in accordance with the rules in force in the country - the participant of the Agreement;

8) Contribution of cooperation with international non-governmental organizations in the field of education and science.

Article 3

Leaders of both HEIs shall exchange all necessary information - including through publications - on the structure and organization of the HEI in order to increase mutual awareness, in this area. Each of the parties in accordance with their national legislation guarantees guests of another Party under this Agreement, any kind of help and support in their country necessary to reach the agreed objectives.

Before the departure of the delegation or group, the Parties stipulate special medical insurance to ensure medical care and any other necessary support for each faculty member, student or technician, in order to take responsibility for it to the host university.

HEIs carry out the exchange of teachers, researchers and technical personnel during the-term of this Agreement, taking into account the qualifications and training of the members of the delegation-or group learning plans, as well as educational and research needs of the University.

Conducting academic exchange and specific joint activities is planned by the Parties no later than two months prior to their implementation and is based on the written invitation of the host Party. Sending a delegation of scientists must be approved by another Party.

HEIs should notify each other about candidates' academics and / or technical workers with the necessary program visits for implementing the above mentioned issues.

Transportation cost in the host country, the cost of food and accommodation are taken by the host party, except for the cases included in the program otherwise agreed between the parties. The parties may also involve third-party organizations and foundations to finance cooperation.

The host university undertakes to promote the participation of students in the University of the Guide Lectures on the subjects of any existing at the host university course. Students, according to the guide of the high schools may choose a number of courses offered by the host university. Each HEI provides coming students with a document certifying the number of visited classes, the courses and the amount of points gained.

By common consent, HEIs determine the system of admission examinations and assessment, which will be applied to coming students. To confirm the exam or course taken by students of one university in another one the legislation in force of each of the member states of Agreement is to be applied.

HEIs involved are to define the mutual obligations with respect to the enrollment of students, tuition fees and HEIs insurance.

Article 4

Host reserves the right to award the coming students of the University involved. In case of disputes on matters specified in this Agreement, the parties will take all measures to solve them by means of negotiations.

Article 5

This Agreement does not exclude other forms of cooperation that can be offered for

discussion by the initiative of each of the Parties. All changes and additions to the Contract are invalid without the written notification of parties to the Agreement.

This agreement is valid for five years, effective from the date of its signing. If none of the parties expresses the desire to terminate the Agreement, it may be extended for the same period by consent of the Parties.



