# KARAMANOĞLU MEHMETBEY UNIVERSITY 2025 – 2026 ACADEMIC YEAR INTERNATIONAL STUDENT ADMISSION QUOTAS, CONDITIONS, AND APPLICATION GUIDE

#### **APPLICATION CONDITIONS**

Candidates for the International Student Program to be admitted to associate and undergraduate degree programs of Karamanoğlu Mehmetbey University may study at the university's present fields and branches as long as they meet the conditions determined by the university, without exception based on nationality, gender, language, or religion. The selection of students for these programs will be made according to the following application conditions within the framework of the basic principles determined by the Higher Education Institution.

# a) Applications of candidates in the following cases are accepted under the condition of being in the final year of high school or being graduates;

- Foreign nationals (excluding foreign nationals who have enrolled in secondary education (high school) institutions in Turkey before the 2022-2023 academic year [excluding embassy schools, international private education institutions listed in the International Schools Information System (MOBIS), and foreign nationals studying in Turkey within the framework of projects conducted by the Ministry of National Education]),
- 2. Those who are born Turkish citizens but have obtained permission from the Ministry of Interior to renounce Turkish citizenship, and those who have children who are not of legal age and are registered in their Turkish citizenship renunciation documents as holders of Recognized Rights under the Turkish Citizenship Law (Article 7 of Law No. 5901 states that "a child born to Turkish citizen parents in marriage within or outside Turkey is a Turkish citizen."), it is useful for candidates applying for admission quotas from abroad to examine the Turkish Citizenship Law),
- **3.** Those who have acquired Turkish citizenship through naturalization while being a foreign national or dual citizen, (with the condition that those who have studied at secondary education (high school) institutions in Turkey have enrolled before the 2022-2023 academic year),
- 4. Turkish citizens who have completed their secondary education (high school) in a foreign country other than the TRNC (including those who have completed all of their secondary education [high school] in Turkish schools opened by the Ministry of Education abroad),

5. TRNC citizens residing in the TRNC and completing their secondary education (high school) in the TRNC with GCE AL exam results, and those who enrolled in colleges and high schools in other countries between 2005-2010 and obtained or will obtain GCE AL exam results.

#### b) Applications of candidates in the following cases will not be accepted;

- 1. Turkish citizens who have completed their secondary education (high school) in Turkey or the TRNC,
- TRNC citizens (except those who have completed all of their secondary education [high school] in TRNC high schools and have GCE AL results or those who enrolled in colleges and high schools in other countries between 2005-2010 and obtained or will obtain GCE AL results),
- 3. Dual nationals whose first nationality by birth is the Republic of Turkey as defined in subparagraph c of paragraph 1 of Article 4 of this Directive, (except for those who meet the conditions specified in subparagraph d of paragraph 1 of Article 4 of this Directive) Dual nationals, one of whose nationality is TRNC [except those who have completed their entire secondary education (high school) in TRNC high schools and have GCE AL results and those who have or will have GCE AL exam results by enrolling and studying in colleges and high schools in other countries between 2005-2010],
- **4.** Turkish nationals studying at schools under the embassies in Turkey and foreign high schools in Turkey, or dual nationals whose first nationality by birth is Turkish as defined in Article 4, paragraph 1, subparagraph c of this Directive,
- 5. TRNC citizens, those who renounced their Turkish citizenship/blue card holders and foreign nationals who will enroll in secondary education institutions in Turkey as of the 2022-2023 academic year (except for embassy schools, international private education institutions included in the MOBİS system and foreign nationals brought to our country within the framework of the project carried out by the Ministry of National Education)

# **APPLICATION PROCEDURES**

Applications of candidates who have taken the 2024 TR-YÖS/2 and 2025 TR-YÖS/1 exams will be accepted. Only online applications will be valid (http://servis.kmu.edu.tr/yos/default.aspx). Applications submitted in person or by mail will not be considered. In electronically submitted applications, the information entered into the

system must be complete and accurate. If it is determined that the application contains incomplete or incorrect information, the application of the candidate will be considered invalid. All announcements regarding application, placement, and registration matters will be published on the webpage of the International Student Coordination Office (https://kmu.edu.tr/yos/tr). All candidates are responsible for following these announcements.

# PREFERENCE, EVALUATION, AND PLACEMENT PROCEDURES

According to the TR-YÖS results, candidates will be able to choose up to 5 programs on the dates specified in the relevant KMU International Student Program Admission Calendar. Preferences cannot be made outside the specified periods. After the application and preference processes end, the applications will be evaluated by the Commission. Applications of candidates who do not meet the application conditions will not be considered. Placement will be made taking into account the preference order of the candidates, starting with the candidate with the highest score. In placement, priority will be given to the candidate with the highest placement score among those who have chosen the same program. If the placement scores of the candidates are equal, priority will be given to the candidate with a birth date closer to the present day (younger age). If the equality persists, the right to enroll will be given to the

candidate who has shown the program in a higher preference. The list of candidates who have won the right to enroll will be announced on the page <u>https://kmu.edu.tr/yos/tr</u>. The results will also be viewable by the candidates in the application system, and acceptance letters will be sent to the candidates who are placed in a program via the email address they provided in the system. If the announced quotas are not filled and deemed necessary by the Commission, an additional announcement may be made. In case of an additional announcement, the student admission requirements and schedule will be announced by the Commission through a separate guide.

#### SPECIAL TALENT EXAM

Candidates who will choose programs that admit students through the special talent exam must first have a sufficient score in the TR-YÖS exam for the preference indicated. After the application and preference processes, in order for a candidate to take the special talent exam, they must have been placed in one of the relevant programs. Candidates placed in programs that admit students through the special talent exam must participate in the special talent exam on the date specified in the KMU International Student Program Admission calendar. The placement process of candidates who do not participate in the special talent exam on the specified date or fail the exam will be canceled, and they will lose the right to be a student in the special talent program. The results of the special talent exam will be announced on the page https://kmu.edu.tr/yos/tr.

#### REGISTRATION

Registration procedures are conducted by the Directorate of Student Affairs. The candidate must personally apply or apply through their legal representative on the specified dates for registration. Students with missing documents will not be registered. Candidates who do not register on the specified dates will be deemed to have waived their right to registration. The following documents are required for registration:

#### **Registration Documents:**

 Equivalence certificate obtained from the provincial directorates of national education within Turkey for candidates who completed their secondary education outside the Republic of Turkey, or from educational counselors/attachés abroad;

- 2. Original high school diploma for candidates who have graduated, or a Turkish translated copy approved by a notary public or the Turkish Republic Embassy / Consulate (candidates in their final year of high school will provide a certified document confirming their graduation);
- 3. Original transcript/grade report approved by a notary public or the Turkish Republic Embassy/Consulate, translated into Turkish (candidates with Kazakhstani and Turkmenistani nationality will not need to provide an additional document as their transcripts are provided along with their diplomas);
- 4. For those under 18: a) Original birth certificate with an apostille, translated into Turkish and approved by a notary public or the Turkish Republic Embassy/Consulate; b) If one parent is absent, an apostilled consent letter from the absent parent, translated into Turkish and approved by a notary public or the Turkish Republic Embassy/Consulate;
- 5. Foreign Language Proficiency Certificate (if available);
- 6. Turkish Proficiency Certificate (if available);
- 7. Original passport or identity card issued by official authorities;
- 8. 4 passport-sized photos;
- **9.** Original GCE AL exam result document for candidates who completed their entire secondary education in high schools in the TRNC;
- **10.** Any other special documents required by the departments and programs for registration.
- **11.** Foreign students who want to have general health insurance can apply to the SSI within the first 3 months of their enrollment in the university, even if they have not received a foreign identity number.

# **TUITION FEE**

The tuition fee will be determined and announced after the publication of the Decision on the Determination of Contribution Fees and Tuition Fees to be taken as Student Contribution to Current Service Costs in Higher Education Institutions in the 2025-2026 Academic Year.

# TURKISH PROFICIENCY AND PREPARATORY EDUCATION

Students who are unsuccessful or do not participate in the Turkish Proficiency and Level Determination Exam conducted by our university must take Turkish preparatory education at TÖMER. The course fees for Turkish preparatory education are determined and announced by

TÖMER. Turkish proficiency and preparatory education are conducted according to the principles specified below.

- 1. Students who have completed their registration must provide a Turkish Proficiency Certificate. Turkish Proficiency Certificates from Yunus Emre Institute, TÖMER Course Success Certificates, or the Proficiency and Level Determination exam result documents issued by our university are valid. Yunus Emre Institute or TÖMER certificates must have been obtained within the last two years as of the registration date at the university. The suitability of these documents is determined by TÖMER.
- 2. Students who cannot present a Turkish Proficiency Certificate must take the Proficiency and Level Determination Exam conducted by TÖMER. The equivalence table (Table-1) prepared by TÖMER will be taken as the basis for evaluation.
- **3.** Students who cannot present a Proficiency Certificate, are unsuccessful in the Proficiency and Level Determination Exam, or do not participate in the exam must take Turkish preparatory education at TÖMER. The duration of Turkish preparatory education is one year. At the end of this period, students who are unsuccessful are given an additional year, and this period is counted as part of the education period. The maximum duration of Turkish preparatory education is two years. If students fail to attend Turkish preparatory education due to absenteeism, their registrations will be canceled.
- 4. Those who wish to receive Turkish preparatory education at TÖMER affiliated with another state university for various reasons must present their registrations and positions within 30 days after leaving TÖMER. The registrations of students who present their documents are considered frozen for one year. These students must submit their Turkish Proficiency Certificates to TÖMER by the end of the last working day of July. Otherwise, their registrations will be canceled.
- 5. The success status of students who receive Turkish preparatory education is sent to the Directorate of Student Affairs by TÖMER at the end of the preparatory education.
