APPLICATION REQUIREMENTS

Applicants to the International Student Program who will be admitted to the associate and undergraduate programs of Karamanoğlu Mehmetbey University may study in the departments and programs determined by the University, provided that they fulfill the conditions specified by our University, without discrimination based on nationality, gender, language, or religion. The selection of students for departments and programs shall be carried out within the scope of the “Principles Regarding the Admission of Students from Abroad” published on the web page of the Council of Higher Education Presidency, Department of Education and Training (<https://egitim.yok.gov.tr/tr/page/594>).

**Applicants Who May Apply:**

**a) Provided that they are in their final year of high school or have graduated;**

1. Foreign nationals, [on the condition that they have not studied / graduated from secondary education (high school) institutions in Türkiye (except for foreign nationals who have completed their entire high school education in embassy schools / international private educational institutions included in the MOBİS system, and foreign nationals who have come to our country within the framework of projects conducted by the Ministry of National Education or the Council of Higher Education)],
2. Those who were Turkish citizens by birth but lost Turkish citizenship by obtaining permission to renounce citizenship from the Ministry of Interior, and those who document that they hold a Blue Card granted upon request to those who lost Turkish citizenship [(on the condition that they have not studied / graduated from secondary education (high school) institutions in Türkiye and the TRNC) (It is recommended that applicants who will apply to quotas for admission from abroad review Article 7 of the Turkish Citizenship Law No. 5901)],
3. Those who acquired Turkish citizenship later while being foreign nationals / dual nationals in this situation [on the condition that they have not studied / graduated from secondary education (high school) institutions in Türkiye and the TRNC],
4. Turkish citizens who have completed their entire secondary education (high school) in a foreign country other than the TRNC (including those who have completed their entire secondary education [high school] in Turkish schools opened abroad under the Ministry of National Education),
5. TRNC nationals; [on the condition that they have not studied / graduated from high schools in Türkiye / high schools in the TRNC implementing the Turkish curriculum] who possess

GCE AL, TR-YÖS, or the criteria specified in the application and admission directives approved by the Council of Higher Education,

shall be accepted.

**b) The applications of the following applicants shall not be accepted:**

1. Turkish citizens who have completed their entire secondary education (high school) in Türkiye or the TRNC,
2. TRNC nationals / dual nationals one of whose nationalities is TRNC [except those who have completed their entire secondary education (high school) in TRNC high schools and have / will have GCE AL results, or TRNC nationals who have completed their entire secondary education (high school) in a foreign country and possess TR-YÖS or the criteria to be used in student admission specified in the application and admission directives approved by the Council of Higher Education],
3. Dual nationals whose first nationality by birth is Turkish as defined in Article 7 of the Turkish Citizenship Law No. 5901 (except those who meet the conditions in subparagraph (a), item 4),
4. Those who are Turkish citizens, or dual nationals whose first nationality by birth is Turkish as defined in Article 7 of the Turkish Citizenship Law No. 5901, and who are studying in schools within embassies in Türkiye or in foreign high schools located in Türkiye
5. a) TRNC citizens and those who renounced Turkish citizenship / Blue Card holders who have studied / graduated from secondary education (high school) institutions in Türkiye and the TRNC,  
b) Foreign nationals who have studied / graduated from secondary education (high school) institutions in Türkiye (except foreign nationals who have completed their entire high school education in embassy schools / international private educational institutions included in the MOBİS system and foreign nationals who have come to our country within the framework of projects conducted by the Ministry of National Education or the Council of Higher Education),

**shall not be accepted.**

In applications, the applicant’s secondary education achievement score (diploma grade) and, if available, the **TR-YÖS Score** obtained within the last two years are taken as the basis.

Applications shall be received electronically: ([https://obs.kmu.edu.tr/oibs/foa\\_app/](https://obs.kmu.edu.tr/oibs/foa_app/)). Applications submitted in person or by post shall not be evaluated. In applications made electronically, the information entered into the system must be complete and accurate. If it is determined that the application contains incomplete or incorrect information, the applicant’s application shall be deemed invalid. All announcements regarding application, examination, placement, and registration shall be published on the website of the **International Student Coordination Office**. All applicants are responsible for following the announcements.

applicant's secondary education achievement status (diploma grade) and, if available, the **TR-YÖS score** are taken into evaluation. If the applicant does not have a TR-YÖS score, the designated portion of the diploma grade is taken as the basis.

In the calculation of the placement score, **75%** of the applicant's foreign secondary education achievement score (diploma grade) and, if available, **25%** of the TR-YÖS score are taken into account. For applicants who will apply only with a foreign secondary education achievement score, **75%** of the secondary education achievement score (diploma grade) is taken. In placement, starting from the applicant with the highest score, primary placement is made up to the number of quotas by taking into account the applicants' order of program preferences.

In case of vacant quotas, an additional announcement may be made and preferences may be received again. The conditions of the additional announcement are determined by the decision of the Commission and the approval of the Senate. Applicants who have been placed in any program in the initial placement cannot benefit from additional preferences.

The foreign secondary education grade point averages of the applicants are evaluated by taking into account the grading system of the country from which they graduated. They are included in the placement score by using the conversion table determined by the University.

Applicants will be able to make a maximum of **3 program preferences** on the dates specified in the calendar included in the KMU International Student Program Application and Registration Guide. Preferences cannot be made outside the periods specified in the calendar.

Applications are evaluated by the Commission. Applications of applicants who are determined not to meet the application requirements are not taken into evaluation.

In placement, among the applicants who have preferred the same program, priority shall be given to the applicant with the higher placement score in determining those who are entitled to final registration in a program. In case of equality, the right of registration shall be granted to the applicant who has listed the relevant program at a higher preference. If equality still continues, priority shall be given to the applicant whose date of birth is closer to the present date (younger age). After the evaluation and placement procedures, the list of applicants who are entitled to register shall be announced on the page <https://kmu.edu.tr/yos/tr>. The results will also be available to applicants through the application system, and a letter of acceptance will be sent via the e-mail address defined in the system to applicants who have been placed in a program. If the announced quotas are not filled or if deemed necessary by the Commission, an additional announcement may be made. In the event of an additional announcement, the student admission requirements and calendar will be announced

by preparing a separate guide by the Commission.

**SPECIAL TALENT EXAMINATION**

An applicant who will prefer programs admitting students through a special talent examination must have a sufficient score for the preference procedures specified in the guide.

In order for an applicant to be able to take the special talent examination after the application and preference procedures, the applicant must have been placed in one of the relevant programs. It is mandatory for an applicant placed in programs admitting students through a special talent examination to take the special talent examination on the date specified in the guide.

An applicant who does not attend the special talent examination on the specified date or who is unsuccessful in the examination shall have their placement cancelled and shall lose the right to become a student in the special talent program.

The results of the special talent examination shall be announced on the page <https://kmu.edu.tr/yos/tr>.

**REGISTRATION**

Registration procedures are carried out by the Department of Student Affairs. For registration, the applicant must apply in person on the specified dates or the application must be made by their legal representative. For registration, it is necessary to obtain a Foreign National Identity (YKN) number from the authorities of the Republic of Türkiye. For YKN, applicants shall be registered provided that the original passport and the identity card obtained in their own country are submitted in person to the Department of Student Affairs.

If there are missing documents (except for the original passport and the identity card obtained in their own country), temporary registration may be made by obtaining an undertaking from the student, provided that they submit them by the specified date.

An applicant who does not register on the specified dates shall be deemed to have waived their right to registration. The following documents are required for final registration:

**Documents Required for Registration:**

1. For applicants who completed their secondary education outside the Republic of Türkiye, an equivalency certificate to be obtained from the provincial directorates of national education within Türkiye, or from education counsellorships/attachés abroad,
2. For applicants who have graduated, the original high school diploma and its Turkish translation approved by a notary public or the Embassy / Consulate of the Republic of Türkiye,

(Applicants who are in the final year of high school shall submit an approved document stating that they are able to graduate.)

3. The original Transcript / Grade Status Document and its Turkish translation approved by a notary public or the Embassy / Consulate of the Republic of Türkiye, (Since the transcripts of applicants who are nationals of Kazakhstan and Turkmenistan are included with the diploma, they shall not submit a separate document.)
4. For those under the age of 18:
  - a) The original apostilled birth certificate and its Turkish translation approved by a notary public or the Embassy / Consulate of the Republic of Türkiye,
  - b) If one of the mother or father is not present, the original apostilled letter of consent of the absent parent and its Turkish translation approved by a notary public or the Embassy / Consulate of the Republic of Türkiye,
5. Foreign Language Proficiency Certificate (if any),
6. Turkish Proficiency Certificate (if any),
7. The original passport or identity document obtained from official authorities,
8. 2 photographs (if any),
9. For TRNC national applicants who completed their entire secondary education in TRNC high schools, the original GCE AL examination result document,
10. Other special documents, if any, required by departments and programs at final registration.

**Tuition Fee:**

It shall be determined by the KMU Senate following the Presidential decision and announced on the website of the International Student Coordination Office. (<https://kmu.edu.tr/yos/tr>)

**TURKISH PROFICIENCY AND PREPARATORY EDUCATION**

Students who fail the Turkish Proficiency and **Level Determination** Examination to be administered by our University or who do not take the examination are required to receive Turkish preparatory education within **KMU TÖMER**. The course fees for Turkish preparatory education are determined and announced by **KMU TÖMER**. Turkish proficiency and preparatory education are conducted in accordance with the principles stated below:

**INTERNATIONAL STUDENT PROGRAM APPLICATION AND REGISTRATION GUIDE**

1. Students who complete final registration are required to submit a **Turkish Proficiency Certificate**. As a Turkish Proficiency Certificate, the achievement certificates of the **Yunus Emre Institute**, **TÖMER** course achievement certificates, or the result documents of the Proficiency and Placement Examinations administered by our University are valid. The documents of the **Yunus Emre Institute** or **TÖMER** must have been obtained within the last two years as of the date of registration at the university. The suitability of these documents is determined by **TÖMER**.
2. Students who cannot submit a Turkish Proficiency Certificate are required to take the Proficiency and Placement Examination to be administered by **KMU TÖMER**. In the evaluation, the equivalence chart (**Table-1**) prepared by **KMU TÖMER** shall be taken as the basis.
3. Students who cannot submit a Proficiency Certificate, who fail the Proficiency and Placement Examination to be administered, or who do not take the examination are required to receive Turkish preparatory education within **KMU TÖMER**. The duration of Turkish preparatory education is one year. Students who are unsuccessful at the end of this period are given an additional one-year period, and this period is counted within the period of education and instruction. The maximum duration of Turkish preparatory education is two years. If students fail Turkish preparatory education due to absenteeism, their registrations are deleted.
4. Those who, for various reasons, wish to receive Turkish preparatory education at **TÖMER** affiliated with another state university are obliged, within 30 days after leaving **TÖMER**, to submit their registration and placement documents/confirmation. The registrations of students who submit their documents shall be deemed frozen for one year. These students are required to submit their Turkish Proficiency Certificate to **KMU TÖMER** by the end of working hours on the last business day of July. Otherwise, their registrations are deleted.
5. The academic standing of students receiving Turkish preparatory education is sent by **KMU TÖMER** to the Department of Student Affairs at the end of the preparatory education.
